<b>1.</b>	<b>Opening</b> KR welcomed the participants to the 44th EFORWOOD IP Board meeting.	
<b>2.</b>	<b>Minutes from IP Board meeting (43)</b> <u>Item 6. Recommendations from the IP Board concerning the FTP C2009 EFORWOOD Side Event</u> KR said that the recent FTP conference had been one of the best so far with much substance in the presentations. The participation in the EFORWOOD ToSIA demonstration side event was, however, low, probably due to the competing the Researchers' Forum and the unfavourable location of the event, but the presentations were excellent and those who took part were interested and content. Tommi Suominen, who together with Franka and Bernard demonstrated the ToSIA database during the conference days, was quite happy, saying there had been plenty of interested visitors.  The other Items had already been taken care of or are covered by Items on the current Agenda.	
<b>3.</b>	<b>Present status concerning data collection and ToSIA analyses</b> <u>Update of present status and actions to be taken</u> ML reported the following:  The Baden-Württemberg Case-study: Data collection is finalized but corrections are being made. The Scandinavian Case-study: Test runs show that nothing is missing but there is still work to do, according to CO; corrections are still being made. The Iberian Case-study: Last day of data collection Nov. 13.	

	<p>The European Case-study: Data collection continues until the end of November.</p> <p>ML said that the data quality can still be improved but there are daily improvements incl. removals of bugs and the miscommunication between the database and the ToSIA tool is overcome.</p>	ML
4.	<p><b>Post EFORWOOD arrangements</b>  <u>Amendment to the Consortium Agreement and MoU for TMUG</u>  KR stated that the last few months had shown a need for more specific and detailed formulations in the Consortium Agreement when it comes to IPR matters going beyond the EFORWOOD project lifetime. In answer to the concerns expressed primarily by FVA and ALUFR, KR had drafted an Amendment to the EFORWOOD Consortium Agreement. In the discussion it was concluded that the EFORWOOD “European Database” should be treated in an equivalent way to the regional data (the Case-study data).
