

| 2. | Minutes from IP Board meeting (46) Items still not attended to: <u>Item 2. Minutes from IP Board meeting (45)</u> <u>Final reporting – project results</u> - The different summary papers mentioned still remain to be done. <u>Item 4. Final reporting – project results</u> <u>Updated situation concerning Ds and PDs</u> KR reminded partners that a great many deliverables that have been delivered in draft version still remain to be delivered in final version. | | <p><i>The Baden-Württemberg Case-study</i> is more or less fixed. However, ML reported that Modules 4 and 5 will have to be left out since the quality of the results is uncertain and there is nobody working on them any longer. The MCA is there and will be included in the Final Publishable Report.</p> <p>No big changes are being made in relation to <i>the Scandinavian Case-study</i> and ML was uncertain if anyone is still working on it any more.</p> <p>Regarding <i>the EU-FWC</i>, the 2005 version is running, but not all what we have promised is included (the analysis for the whole chain). More efforts are required for the country groups. The TMUG meeting itself was suggested to take place in the morning of September 6 (half-day) and the rest of the time (1,5 days) could be spent on ToSIA training. - The meeting was decided to take place in Finland. HW to investigate possible locations in Helsinki and come back to KR after Easter. <p><u>New follow-up activities</u> KR said he had only a few possible initiatives to report (a COST action, a possible Marie Curie Network application, WoodWisdom Net applications) and he asked everybody soonest to come back to him with additional initiatives.
